The Bidder's average financial turnover in the same name and style during last three financial years (i.e. 2022-23, 2023-24 and 2024-25) should not be less than INR **500 lakhs.** Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
- 3. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature (similar nature means Effluent treatment plant /Effluent treatment plant with recycle RO plant / STP with Recycle RO/WTP with RO/RO for WTP or ETP or STP) either of the following:
