Eligibility Criteria

- 1** The bidder in the same name and style should be in the business of Bituminous road work for a period of three as on 31.03.2020
- 2** The bidder shall be registered with CPWD or state PWD as road contractor category I or II or III.
- 3** The bidders should have successfully completed similar works as under during the last 03 years ending 31/03/2020.
 - 3 (Three) similar completed works each costing not less than Rs.16 Lakhs.

OR

 - 2 (Two) similar completed works each costing not less than Rs. 24 Lakhs.

OR

 - 1 (One) similar completed work of cost not less than Rs. 32 Lakhs
- 4** The bidders' average financial turnover for last three financial years (2017-18, 2018-2019, 2019-2020) should not be less than 150 lakhs
- 5.** The bidder shall have valid GST registration No.

In addition to above following documents /information should also be submitted along with bid by bidders for evaluation /determination of their eligibility.

- The bidder shall furnish a copy of the Income Tax returns and the Income tax clearance certificate for the three previous years, in original or certified true copies along with PAN for income tax purpose and GST registration certificate.
- Copy of the TDS certificate issued by clients to substantiate the claim for the value of works executed.

Even though the bidder meet the specified criteria, it may be disqualified if it has Record of poor performance such as abandoning the works, not properly completing the contracts, inordinate delays in completion or financial failure etc.
