1. The Bidder in the same name and style should be in the similar business for at least five financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences.
2. The Bidder's average financial turnover in the same name and style during each of the last three financial years (i.e. 2016-17, 2017-18 and 2018-19) should not be less than INR 50 Crores. Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
3. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature (Effluent treatment plant) during the last five years ending last day of the month previous to the month in which bid is opened, either of the following: -

a) One contract costing not less than INR 15.50 Crores

- a) One contract for each costing not less than INR 2.4 Crores

- b) Two contracts each costing not less than INR 1.8 Crores

**OR**

- c) Three contracts each costing not less than INR 1.5 Crores

Bidder can purchase either pack-I or pack-II. bidder can also purchase both pack-I and II. The tender fees and EMD shall be separate for both the pack.

### **2. Submission of bid**

This invitation of bids is open to all Bidders who meet the minimum eligibility criteria specified in this bid document.

### **3. Bid Security/earnest money deposit(EMD)**

All bids must be accompanied by bid security (EMD) of Rs 22 lakhs for pack -I and 3 lakhs for pack -II. The EMD should be in the form specified in the bidding document & incorporated in the technical bid (Cover I). Bids not accompanied with EMD, shall be summarily rejected.

### **4. Opening of Bids**

This is a two stage bid. All the bidders shall submit the bids in cover I – Technical bid and Cover II- Price Bid. The technical bid (Cover I) shall contain all the details except for the price. After evaluation of technical bids and confirming the requirements, the eligible bidders shall be notified the option of revising the price bid. Only technical bids shall be opened initially on the date and time specified above in the presence of representatives of interested bidders. The date and time of opening of the price bid (Cover II) & its revision if any shall be communicated later to all eligible bidders.
