The bidders must meet the following minimum qualification criteria:

A. For PACK -I (Sr.no.1)

1. The Bidder in the same name and style should be in the similar business for at least five financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences.
2. The Bidder's average financial turnover in the same name and style during each of the last three financial years (i.e. 2016-17, 2017-18 and 2018-19) should not be less than INR 800 Lakhs. Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
3. Bidder shall be either OEM of Transformers, 66 KV Breakers, HT panel or their authorized (Manufacturers authorization form must be submitted)

OR

A Class Electrical EHV contractor having valid license

4. Bidder should be GETCO approved.
5. The Bidder in the same name and style shall have successfully executed / completed at least 3 numbers of contracts of similar nature (66 KV and above substation) during the last seven years ending last day of the month previous to the month in which bid is opened, either of the following: -

a) One contract costing not less than INR 320 Lakhs

OR

b) Two contracts each costing not less than INR 240 Lakhs

OR

c) Two contracts each costing not less than INR 160 Lakhs

Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
3. Bidder should have a license of electrical contractor
4. The Bidder in the same name and style shall have successfully executed / completed at least 3 numbers of contracts of similar nature (11 KV and above substation) during the last seven years ending last day of the month previous to the month in which bid is opened, either of the following: -
 - a. One contract costing not less than INR 480 Lakhs

OR

 - b. Two contracts each costing not less than INR 360 Lakhs

OR

 - c. Three contracts each costing not less than INR 240 Lakhs

Copy of the purchase orders and their Completion certificates for the works mentioned in the qualification criteria shall also be submitted.

5. The bidder should have valid registration under various acts that may be applicable for the contract proposed. This shall include but not limited to income tax, GST, Employee State Insurance, Contract Labour, Provident Fund etc.

3. Bidder shall be either OEM of DG Sets or their authorized (Manufacturers authorization form must be submitted)
4. The Bidder in the same name and style shall have successfully executed / completed at least 5 numbers of contracts of similar nature (DG SETS) during the last seven years ending last day of the month previous to the month in which bid is opened, either of the following: -
 - a. One contract costing not less than INR 400 Lakhs

OR

 - b. Two contracts each costing not less than INR 300 Lakhs

OR

 - c. Three contracts each costing not less than INR 200 Lakhs

Copy of the purchase orders and their Completion certificates for the works mentioned in the qualification criteria shall also be submitted.

5. The bidder should have valid registration under various acts that may be applicable for the contract proposed. This shall include but not limited to income tax, GST, Employee State Insurance, Contract Labour, Provident Fund etc.

Bidder has to purchase pack –III separately. The tender fees and EMD shall also be separate for all the packs.

2. Submission of bid

This invitation of bids is open to all Bidders who meet the minimum eligibility criteria specified in this bid document.

3. Bid Security/earnest money deposit(EMD)

All bids must be accompanied by bid security (EMD) as mentioned in tender notice. The EMD should be in the form specified in the bidding document & incorporated in the technical bid (Cover I). Bids not accompanied with EMD, shall be summarily rejected.

This is a two stage bid. All the bidders shall submit the bids in cover I – Technical bid and Cover II- Price Bid. The technical bid (Cover I) shall contain all the details except for the price. After evaluation of technical bids and confirming the requirements, the eligible bidders shall be notified the option of revising the price bid. Only technical bids shall be opened initially on the date and time specified above in the presence of representatives of interested bidders. The date and time of opening of the price bid (Cover II) & its revision if any shall be communicated later to all eligible bidders.
