The bidders must meet the following minimum qualification criteria:

1. The Bidder should be either OEM or their authorized representative in india. Original Equipment (solar module) Manufacturers authorization certificate should be submitted if the bid is submitted by Indian authorized representative of OEM.
2. The Bidder in the same name and style should be in the similar business for at least three financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences.
3. The Bidder's average financial turnover (Summation of three years turnover divided by 3) in the same name and style during each of the last three financial years (i.e. 2020-21, 2021-22, 2022-23) should not be less than INR **100 Lacs for SLICE A,C and 500 Lacs for SLICE B**. Balance sheet and income tax return as a documentary evidence shall be provided for the proof of financial turnover.
4. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature (SPV Power Plant) during the last five years ending last day of the month previous to the month in which bid is opened, either of the following: -

FOR SLICE A,C:

- a) One contract for Solar Power Plant of minimum capacity 200 KW AC.

OR

- b) Two contracts for Solar Power Plant each minimum capacity 160 KW AC.

OR

- c) Three contracts for Solar Power Plant each minimum capacity 120 KW AC.

FOR SLICE B:

- a) One contract for Solar Power Plant of minimum capacity 1000 KW AC.

OR

- b) Two contracts for Solar Power Plant each minimum capacity 800 KW AC.

OR

- c) Three contracts for Solar Power Plant each minimum capacity 600 KW AC.

Copy of the purchase orders and their Completion certificates for the works mentioned in the qualification criteria shall also be submitted.

5. The bidder should have valid registration under various acts that may be applicable for the contract proposed. This shall include but not limited to income tax, GST, Employee State Insurance, Contract Labour, Provident Fund etc.

6. In addition to the above, the following information / documents should also be submitted along with the bid by the bidder for evaluation / determination of their eligibility:
 - a. Copy of income tax returns for three financial years as mentioned above in original or certified true copies, along with Permanent Account Number (PAN) for income tax purpose.
 - b. Copy of TDS certificate issued by the clients to substantiate the claim for the value of works in the private sector.
7. Even though the Bidder meet the specified criteria, the bid may be disqualified in case the bidder has:
 - a) Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualifications.
 - b) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failure etc.

1. Purchase of bidding Document:

Interested bidders can purchase the bidding documents in person between 11:00 - 16:00 hours on any working day with in tender sale period specified above on payment of non refundable tender fees of Rs 5000 + 18 % GST by DD/RTGS (in favour of Banaskantha District Co-operative milk Producers' union Limited payable at Palanpur) or by paying non refundable fees of Rs 5000 + 18% GST in accounts department of Banas dairy and submission of payment receipt.

In case bidder wishes to purchase the bid document through courier/ post they have to submit a DD of Rs 5000 + 18 % GST + Rs 500 towards the courier charges in favour of Banaskantha District Co-operative milk Producers' union Limited payable at Palanpur. The payment can also be transferred through RTGS at the following bank details. The pre-bid meeting can also be termed as technical bid (Cover I) and shall contain all the technical details except for the price.
