1. Eligibility and Qualification requirements:

Any bidder may bid for Part-I or Part-II or for combined Part-I & Part-II, however they need to qualify for the same as per given qualification criteria,

In case the bidder has participated in combined Part-I & Part-II, and found non eligible against the criteria, then he shall have no right to qualify for Part-I or Part-II individually, therefore bidder should verify their credentials required against the eligibility & qualification criteria given in our tender document.

The bidders must meet the following minimum qualification criteria:

❖ For Part-I

1. The Bidder in the same name and style should be in the similar business (Edible Oil Projects) for at least **three** financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences
2. The Bidder's average annual financial turnover in the same name and style for the last three financial years (2018-19, 2019-20 and 2020-21) should not be less than **500 lakhs**, Certified copy of the Annual report (audited balance sheet and profit & loss account) as a documentary evidence shall be provided for the proof of financial turnover.
3. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature* either of the following: -

One contract costing not less than **Rs. 500 lakhs**

OR

Two contracts each costing not less than **Rs. 325 Lakhs**

OR

Three contracts each costing not less than **Rs. 250 Lakhs**

❖ For Part-II :

1. The Bidder in the same name and style should be in the similar business (Edible Oil Projects) for at least **three** financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences
2. The Bidder's average annual financial turnover in the same name and style for the last three financial years (2018-19, 2019-20 and 2020-21) should not be less than **250 lakhs**, Certified copy of the Annual report (audited balance sheet and profit & loss account) as a documentary evidence shall be provided for the proof of financial turnover.

3. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature* either of the following: -

One contract costing not less than	Rs. 250 lakhs
OR	
Two contracts each costing not less than	Rs. 160 Lakhs
OR	
Three contracts each costing not less than	Rs. 125 Lakhs

❖ **For combined Part-I & Part-II :**

1. The Bidder in the same name and style should be in the similar business (Edible Oil Projects) for at least **three** financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences
2. The Bidder's average annual financial turnover in the same name and style for the last three financial years (2018-19, 2019-20 and 2020-21) should not be less than **750 lakhs**, Certified copy of the Annual report (audited balance sheet and profit & loss account) as a documentary evidence shall be provided for the proof of financial turnover.
3. The Bidder in the same name and style shall have successfully executed / completed contracts of similar nature* either of the following: -

One contract costing not less than	Rs. 750 lakhs
OR	
Two contracts each costing not less than	Rs. 490 Lakhs
OR	
Three contracts each costing not less than	Rs. 375 Lakhs

- ❖ If the works are done overseas, then the value of work shall be derived in Indian rupees by multiplying the foreign currency with average exchange rate of the year in which the works have been completed.
- ❖ ***Similar Nature:** Similar nature of works means the works executed for Edible Oil Mill Projects,
- ❖ The Bidder should have valid registration under various Acts that may be applicable for the contract proposed. This shall include but not limited to Income Tax, GST, Employee State Insurance, Provident Fund etc. This is applicable for bidders from India. For bidders of foreign origin, they should have all legal registrations of their country. The same shall be submitted alongwith the bid.

Where the works are executed for private company the bidder, in support of their eligibility should submit the copy of the relevant TDS certificate received from their clients for the works.

Where the works are executed in foreign currency (for India or outside) then equivalent value of order in INR shall be derived by multiplying the value of works executed in foreign currency by average foreign exchange rate in INR of the year in which the project is completed.

Bidders shall submit the certified copy of the Annual report for the previous completed three years (2018-2019, 2019-2020 and 2020-21) audited balance sheet and profit & loss account along with their PAN and GST registration Number.

In the event of merger and acquisition causing change in the name of the bidder the copies of the balance sheets of the previous completed three years (audited balance sheet and profit & loss account) of earlier company whose business was transferred to the new company shall be furnished.

All the bidders must submit completion certificate towards the proof of their eligibility and qualification requirements.

Even though the Bidder meets the specified criteria, the bid may be disqualified in case the bidder has:

- a) Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualifications.
- b) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failure etc.
- c) Bidder or its collaborator who have been black listed/ debarred/ removed from any organization/ agency or whose contract has been rescinded during the last three years or undergoing major litigation regarding debarring or rescinding of their work in any court of law will not be considered for qualification. For that effect the bidder has to submit the notarized affidavit.

3. Submission of bid

This invitation of bids is open to all suppliers who meet the minimum eligibility criteria specified in this bid document.

4. Bid Security / Earnest Money Deposit (EMD)

All bids must be accompanied by bid security (EMD) of Rs. **11 Lakhs for Part-I** and **4 lakh for Part-II** and **15 Lakh for combined Part-I & II**, and the same should be in the form specified in the bidding document & incorporated in the technical bid (cover I).Bids not accompanied with EMD, shall be summarily rejected. EMD and eligibility documents should be submitted in separate cover.

5. Opening of Bids

This is a two stage bid. All the bidders shall submit the bids as per below

- **COVER I – TECHNICAL BID along with EMD & Eligibility Documents,**
- **COVER II- PRICE BID.**

The technical bid (Cover I) shall contain all the details except for the price. After evaluation of technical bids and confirming the requirements, the eligible bidders shall be notified the option of revising the price bid. Only technical bids shall be

opened initially on the date and time specified above in the presence of representatives of interested bidders. The date and time of opening of the price bid (Cover II) & its revision, if any shall be communicated later to all eligible bidders.
