Eligibility and Qualification requirements for bid reference:

BNS/ENGG/ 2021/ SPV POWER PLANTS:

For 5 & 10 KW:

The bidders must meet the following minimum qualification criteria:

1. Bidder should be in the similar business.
2. Bidders who have successfully completed solar power plants of similar nature (at least 05 plants of more than 3 KW rating).
3. The Bidder should have valid GST and Income tax registration.
4. Bidders must submit completion certificate and Copy of the PO towards proof of their eligibility and qualification requirements
5. Where the works are executed for private company the bidder/s, in support of their eligibility should submit the copy of the relevant TDS certificate received from their clients for the works.

For more than 10 KW:

The bidders must meet the following minimum qualification criteria:

1. The Bidder in the same name and style should be in the similar business for at least two years on the date of opening of the bid.
2. The Bidder should have successfully completed contracts of similar nature, either of the following: -
 - a) Three contract of 40 KW and above

OR

 - b) Five contracts of 25 KW and above

OR

 - c) Ten contracts of 15 KW and above
3. The Bidder should have valid GST and Income tax registration.
4. Where the works are executed for private company the bidder, in support of their eligibility should submit the copy of the relevant TDS certificate received from their clients for the works.
5. All the bidders must submit completion certificate and Copy of the PO towards the proof of their eligibility and qualification requirements.

6. Even though the Bidder meet the specified criteria, the bid may be disqualified in case the bidder has:

a) Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualifications.

b) Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion or financial failure etc.

Note: Bidders who are eligible for more than 10 KW plant are automatically eligible for 5 & 10 KW plant.

1. Purchase of bidding Document:

2. Pre bid meeting

A pre bid meeting is proposed on 31/08/2021 @1100 hours at Banasdairy, Palanpur. Bidder should submit their points by 29/08/2021 requiring clarification in the pre bid meeting by mail /letter to the address mentioned below at Sr.No. 7. These points shall be submitted in the form of technical and commercial deviations with their justifications. The formats are enclosed in respective section of the bidding document. Points requiring clarifications submitted after 29/08/2021 shall not be considered

and discussed. All the bidders who wish to submit the bid should attend the pre bid meeting. After the pre bid meeting the summary of points discussed with clarifications shall be circulated to all the bidders who have purchased the tender document. These points in addition to the tender document requirement shall be considered for submitting the techno commercial offer on the stipulated date mentioned in the tender notice. Post pre bid meeting and clarifications provided by purchaser No deviation either technical or commercial shall be accepted. Bidder while submitting their techno commercial offer should submit signed Technical and commercial deviation forms duly mentioned as "NO DEVIATIONS"

3. Submission of bid

This invitation of bids is open to all bidders who meet the minimum eligibility criteria specified in this bid document.

4. Bid Security / Earnest Money Deposit (EMD)

All bids must be accompanied by bid security (EMD) as mentioned in tender notice. The EMD should be in the form specified in the bidding document & incorporated in the technical bid (Cover I). Bids not accompanied with EMD, shall be summarily rejected.

5. Opening of Bids

This is a single stage bid in which Pre-bid meeting shall be arranged for the technical and commercial discussion before bidding. All the bidders shall submit the bids in Cover I - Technical bid and Cover II- Price Bid. The technical bid (Cover I) shall contain all the technical details except for the price. Both bids shall be opened on the date and time specified above in the presence of representative of interested bidders. There shall be pre-bid meeting on 31/08/2021.
