The bidders must meet the following minimum qualification criteria:

- 1. The Bidder in the same name and style should be in the similar business for at least five financial years. In case of change of name of bidder by merger / acquisition / change in status, the bidder has to submit documentary evidences.
- 2. The Bidder's average annual financial turnover in the same name and style during the last three financial years (i.e. 2019-20, 2020-21 and 2021-22) should not be less than INR 500.00 Lakhs. Certified copy of the Annual report (audited balance sheet, income tax return and profit & loss account) as a documentary evidence shall be provided for the proof of financial turnover.
- 3. The Bidder in the same name and style shall have successfully executed / completed similar nature (Expansion Dairy plant project) during the last five years ending last day of the month previous to the month in which bid is opened, either of the following:
 - a) One contract costing not less than INR 152 Lakhs

OR

b) Two contracts each costing not less than INR 114 Lakhs.

OR

c) Three contracts each costing not less than INR 76 Lakhs.

Similar nature of works means the Bidder in the same name and style, should have successfully designed, supplied, installed and commissioned automated Dairy plant.
