- 8. - 18. If any dispute or differences arises at any time between the two parties in respect of or concerning anything contained or arising out of contract shall be referred to sole arbitrator our Managing Director. The decision of the arbitrator shall be final and binding on both the parties.

(1) Validity of Rate Contract:

Validity of the contract is for **TWO Year** from the date of work order. In case of any need felt, Banas Dairy reserves the right to extend the contract.

(2) Scope of Work:

1. Electrical motors rewinding for all burned motors.

2. The offered rates shall be inclusive of material used for rewinding. (Transportation of Motor shall be in Banas Dairy Scope.)

3. The objective of the agreement is to ensure that all plants of our Union functioning smoothly. Hence it is very important to adhere to delivery schedule.

4. Service offered shall be in accordance with the service instructions and standard and good maintenance practices.

Contract specific Terms and Condition:

Breakdown, Fault or complaint may be reported through phones, mails, fax, or SMS.

- Bidder should have to complete rewinding work as per the instruction issued time to time by officers of Union.
- The offered rate of Electrical motor rewinding shall be fixed and remain unchanged during the period of BIANNUAL RATE CONTRACT.
- In case of any plant is not satisfied with the services of any specific engineer/ technician, Bidder take necessary steps for improving the performance of engineer/ technician.

- Rewinding warranty will be one year from the date of rewinding, Bidder/contractor will be required to do rewinding free of cost in case of any fault detected in rewinding.
