### Background and Scope of the Assignment:

We, Banaskantha District Co-operative Milk Producer's Union Limited, commonly known as Banas dairy, are seeking the services of an experienced and knowledgeable Consultant to assist with the process of obtaining a small finance bank license. The Consultant should possess extensive industry experience and possess a thorough understanding of RBI regulations and legal requirements pertaining to the incorporation of Small Finance Bank.

The scope of work includes carrying out a detailed eligibility analysis and review of Banas dairy's profile, formation of a separate company and its business plan, preparation, and submission of the application of the small finance bank to the RBI, reviewing and providing feedback on necessary documentation, ensuring compliance with RBI regulations and legal requirements, and liaising with the RBI on behalf of the Banas Dairy.

The overall responsibility of the Consultant will encompass all the jobs required for incorporation of Small Finance Bank with strict control avoiding any time / cost overrun. The Consultant will have to work in close coordination with Banas Dairy and its deputed Team and all major decisions shall be taken in consultation with them.

Competent and capable consultants who meet all the requirements are invited to submit their Expression of Interest (EOI), along with the necessary information (refer appendix 1 & 2) and documents as outlined to the DGM (F & A, Audit) at Banas Dairy, Post Box No. 20, Palanpur – 385001. The deadline for submission is **09.06.2023 up to 15 hrs**. Based on the received EOIs, limited tenders will be issued to the shortlisted consultants who are deemed competent and capable, for the purpose of awarding the contract.

Details of Scope of work, Pre-Qualification Requirements and other Requirements are as under:

## 1.0 Scope of work:

- Stage-1: Carrying out detailed eligibility analysis and review of Profile of Banas Dairy, its directors and eligibility criteria of RBI and submission of its report to Banas Dairy, Management.
- Stage 2: Procuring requisite legal approvals from Gujarat government for forming a company and making investment in proposed company for forming up a Small Finance Bank by Banas Dairy.
- Stage 3: Formation of Separate Company & its Business Plan and Preparation & submission of an application of the Small Finance Bank to the RBI.
- Stage 4: Reviewing and providing feedback on the necessary documentation required by the RBI for small finance bank application.
- Stage 5: Ensuring compliance with RBI regulations and legal requirements for Small Finance Bank.
- Stage 6: Responsible for application process, including liasioning with the RBI on behalf of the Banas Dairy.
- Stage 7: Providing an action plan and guidance to Banas Dairy for meeting legal and regulatory requirements post-license issuance, including but not limited to maintenance of necessary documentation and records, adherence to reporting requirements, and implementation of effective risk management and internal control systems. ## **3.0 Bid Requirements:**

3.1 In this EOI, the following terms shall be interpreted as indicated:

"Bid" means response to this EOI

"Bidder" means the respondent to this EOI.

3.2 The Bidder/consultant shall enclose documents along with the bid to show that it has previous experience in having successfully completed in the recent past works of similar nature together with the name of OWNER. It shall be the responsibility of the Bidder to fill complete, correct and accurate information in line with the requirements/stipulations of the EOI Document, regarding their past experience and other information required to facilitate due evaluation/consideration of their bids. In case any essential information given by a bidder/consultant is found to be incorrect or a misrepresentation, the bid is likely to be rejected as not responsive, and if the bid has resulted in a contract, the contract is liable to be terminated.

3.3 The selected consultant (bidder) shall not be allowed to participate in "indirect participation". An `indirect" participation shall include a participation through an `affiliate" or as a subcontractor, consultant. the expression `affiliate" for the purposes of this clause will include any person or company or association (howsoever designated) which is a member of the consultant (if the consultant is a joint venture or consortium) or who or which directly or indirectly holds 10% (ten percent) or more of the capital or voting capital of the consultant (if the consultant or any of its members is a company or body corporate) or who or which is a consultant or subcontractor of the consultant with regard to this project, and any contractor/ supplier of which the consultant or an affiliate is a member (if the contractor/ supplier is a consortium or joint venture) or in which the consultant or an affiliate directly or indirectly holds

10% (ten percent) or more of the capital or voting capital (if the contractor/ supplier or any of its members is a company or body corporate).

3.4 The bidder shall have to sign a Secrecy Agreement / Non-Disclosure Agreement with Banas Dairy whenever called for.

3.5 The Consultant shall be deemed:

(a) to have understood the work and all available information relating thereto (including any such information provided by or on behalf of Dairy), and

(b) to have satisfied itself, before submitting its bid, as to the form and the extent and nature of work and manpower necessary for the completion of the Works, and other infrastructure and it may require, and

(c) generally to have obtained all necessary information as to risks, contingencies and all other circumstances which may influence or affect its bid.

3.6 Furthermore, the CONSULTANT shall be deemed to have taken into account, prior to entering into the Contract, any further information provided by Banas Dairy before the Effective Date.

3.7 No failure by the CONSULTANT to become knowledgeable about or to discover matters which affect the Works shall relieve it of its obligations under the Contract.

3.8 The Banas Dairy shall not be liable to the CONSULTANT for claims for additional payments under the Contract on account of matters affecting the Works, and/or any associated activities, which the CONSULTANT: (a) should have determined and understood prior to submission of its bid for the performance of the Works on the basis of information provided by or on behalf of Banas Dairy or (b) Could reasonably be expected to have been aware of as an experienced CONSULTANT in the field of the kind of works to be performed under the Contract.
