## 1. Eligibility and Qualification requirements:

The bidders must meet the following minimum qualification criteria:

- 1. The bidder should be in the business in the same name and style for at least since last Three financial years at time of bid opening. In case of change of name of bidder by merger/acquisition/change in status, the bidder may be eligible based on the documentary evidence.
- 2. The Bidder's average annual financial turnover in the same name and style during the last three financial years (i.e. 2019-20, 2020-21 and 2021-22) should not be less than Rs. 100 Lakhs.
- 3. The Bidder in the same name and style shall have successfully executed / completed contracts of the following: -

One contract costing not less than Rs.80 lakhs
OR
Two contracts each costing not less than Rs.60 lakhs
OR
Three contracts each costing not less than Rs.40 lakhs

- 4. All the bidder must submit completion certificate along with copy of the PO towards the proof of their eligibility and qualification requirements.
- 5. Even though the bidder meets the specified criteria the bid may be disqualified in case of the bidder has:
  - Made untrue or false declaration in the forms, statements and attachments submitted in proof of their qualification.
  - Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in competitions periods.
