- 1. Purchase of Tea at Kolkata/ Siliguri/ Guwahati Public Auction.
- 2. Blending of Tea as per approved standard samples.
- 3. Packing and transportation of Tea to the Palanpur

Supplier's Responsibilities:

- 1. Provide a Sample of the Tea to the Banas dairy for Approval.
- 2. Purchase of tea, on behalf of Banas Dairy as per the requirement of Banas Dairy from the auction house.
- 3. Blending of different lots of Tea as per the Banas dairy Specifications of Flavour,
 Taste, Strength, Colour, etc. Subject to seasonal variations.
- 4. Guide us

Banas Dairy Responsibilities

- 1. Providing requirements of Tea well in advance to enable procurement of the same.
- 2. Providing timely feedback on the Quality of Tea.
- 3. Payment to the party within **30 days** from the receipt of the stock at our premises.
- 4. Payments will be made to the party, irrespective of the location of the Goods.
- 5. Freight charges from the place of the auction will be paid by Banas Dairy at the actual rate.

MODE OF OPERATION

- Banas Dairy will inform the requirement of tea well in advance to party along with the maximum acceptable average Price and Sample of the Tea Quality.
- 2. Party will procure the tea on behalf of Banas Dairy through Kolkata/ Siliguri/ Guwahati Public Auction and blend it, to match the sample given by Banas Dairy.
- 3. Party will send the sample for approval to Banas Dairy.

- 4. Banas Dairy will judge the Sample and convey its approval/ rejection of the Sample by fax/mail/email
- 5. In case of rejection, the party will re-procure/ re-blend the tea and send the sample for approval.
- 6. Upon approval of the sample, the party will properly pack the tea in bags and send it to Banas Dairy through Road transport. The transportation cost will be reimbursed to the supplier on successful (quality and quantity) stock receipt. Responsibility for Stock (Quality & Quantity) will be with the Supplier till it is received at Banas Dairy Palanpur
- 7. Party will also send all the necessary papers to the Banas dairy for Payments and collection of Tea including auction papers.
- 8. The tea will be checked against the approved sample upon receipt at Banas Dairy. In case of rejection, the party will replace the tea at no additional cost to Banas Dairy.
- 9. The weight of the tea receipt will be taken as the final weight and shortages will be recoverable from the supplier.
- 10. Banas Dairy will make payment to Party through RTGS.
- 11. ₹ 5,00,000/ to be given by the successful bidder as a security deposit which will be refunded after the successful completion of the contract without paying any interest.
